

## Official Contest Rules – KBDR “LA LEY 100.5” – Prende El Bote!

- 1. NO PURCHASE NECESSARY TO PARTICIPATE OR WIN. VOID WHERE PROHIBITED, SOME RESTRICTIONS APPLY. Open to Laredo and the surrounding areas residents only.**
- 2. SPONSORS:** R Communications, including station KBDR “LA LEY 100.5” located at **107 Calle Del Norte, Suite 212, Laredo, TX 78041**. The administrator of the Contest is **R Communications**.
- 3. DATES OF THE CONTEST:** KBDR “LA LEY 100.5” - “Prende El Bote” takes place **Monday, September 23, 2019 to Thursday, November 14, 2019. Grand Prize drawings will be on Thursday, September 26, 2019, Thursday, October 10, 2019, Thursday, October 24, 2019, and Thursday, November 7, 2019.**
